Arkansas State Plant Board Update From December 30

The Arkansas State Plant Board met Monday, December 30, to discuss the lawsuit that was filed by Monsanto against the Board. Pulaski County Circuit Judge Chris Piazza declared that the makeup of the Board is unconstitutional due to the fact that the governor does not appoint 9 of the Board positions. Those positions are appointed by organizations like ours. For a short-term fix, the Board decided to ask the Attorney General's office to file an appeal and ask

for a stay. Judge Piazza's comments after the case lead me to believe that this process should work in our favor: Piazza said he was inclined to stay his ruling while, or if, the case is appealed to the Arkansas Supreme Court because the Plant Board has other responsibilities beyond devising and enforcing pesticide and herbicide use regulations. With that said, I think we need to take a hard look at our process and be proactive in avoiding this from happening in the fu-

ture. Judge Piazza's finding opens the door for problems down the road. I know that most of you believe that the integrity of this Board is protected by the fact that it is not a solely appointed Board by the Governor. I have no issues with our current Governor, but we do not know what the future brings in that role. The wrong person in the Governor's seat could be highly detrimental to our industry. I will keep you posted as I get new information.

Arkansas State Plant Board Update From December 11

The Arkansas State Plant Board had a special called meeting on Wednesday, December 11 at the Embassy Suites in west Little Rock. The purpose of the meeting was to allow members from the public to comment on the proposed dicamba rules for the 2020 growing season. In summary, we will have another May 25 cutoff date, and growers will not be able to use the older formulations after April 15.

The Arkansas State Plant Board had a special called meeting on Wednesday, December 11, at the Embassy Suites in west Little Rock. The purpose of the meeting was to allow members from the public to comment on the proposed Dicamba rules for the 2020 growing season. The proposed rule had a May 25 cutoff date for in crop use and also restricted the use of older formulations of dicamba for burn-down after April 15. There were also additional spray record requirements that required each application of dicamba be recorded electronically on the Plant Board's website, and there was an additional requirement for each applicator to provide a GPS spray map showing where each swath was applied. We had a similar public comment meeting earlier in the year in February which included a room full of

people that were given the opportunity to make comments for and against the dicamba rule. The February meeting lasted all day and included some very tense moments. We only had about 1/3 of the people attend this past Wednesday, and the meeting was over at lunch. About 1/2 of the comments came from home owners or from organizations like the Audubon Society who were concerned about horticulture plants and gardens. Most of these were actually against all pesticides and made it clear in their comments. This is scary as I expect our industry to continue to get challenges. Most of the comments that were for dicamba were actually against the new rules as well. While most who spoke would like to follow the federal label, they are satisfied with meeting in the middle with a

cutoff date. However, there was a great deal of opposition for the new record keeping requirements. First of all, many of our growers do not have the equipment to provide spray swath GPS maps. Many felt that this would create an unfair disadvantage for the smaller growers. There was also great concern about the electronic filing of individual spray records. One of the concerns was around whether or not those records could become available by way of the FOI act to the public. This could cause some great exposure to our growers. After a short discussion on the record requirements, the Board voted 13-1 to adopt the new rule without the new spray record requirements. In summary, we will have another May 25 cutoff date, and growers will not be able to use the older formulations after April 15.

Arkansas Crop Protection Association Research Conference 2019

The ACPA Research Conference held on November 19-20 was a very enjoyable and informative event. In addition to a great agenda of speakers the group also had the opportunity to visit the Ozark Beer Company. A total of 28 presentations were included in the 2-day event that featured graduate student participation from undergraduate, masters and doctoral candidates. Winners of the competition

included: undergraduate winners first—G. Smith (“Nozzle Type and Arrangement Effect on Spray Coverage”) and second—A. Whitfield. Masters competition winners in first places—M. C. Castner (“Impact of Dicamba Exposure on Reproductive Rice”) and D. E. Kirkpatrick (“Evaluating the Economic Impact of Soybean Following Winter Cover Crops vs Double Cropped Soybean”), second

places—J. A. Patterson and D. Bolton, third place—J. W. Beesinger and T. H. Avent. PhD competition winners were first—J. L. Chlapecka (“Managing Nitrogen in Furrow Irrigated Rice Production”), second—G. L. Priess and third—J. Kouame. First place winners will present their research at the Arkansas Crop Management Conference.



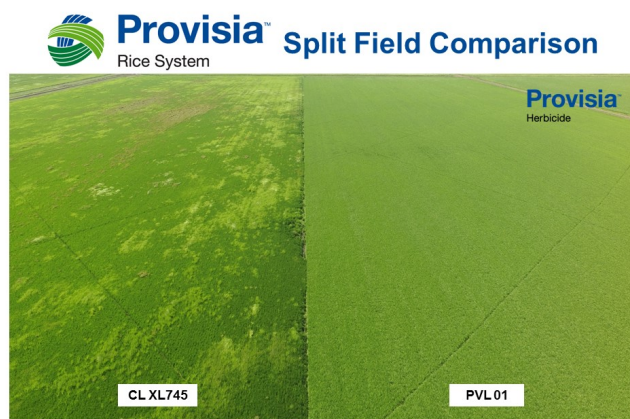
Stewardship will be Key for the Provisia® Rice System
